



THIS MEMORANDUM OF UNDERSTANDING ('MOU') is made at Hubli, Karnataka, India on this 12th day of November 2020 by and between:

Deshpande Educational Trust, a charitable trust incorporated under the Indian Trusts Act 1882, and having its principal office at Airport Road, Hubballi, Karnataka 580030 India, (hereinafter "Deshpande Skilling") duly represented by its Chief Operating Officer, Mr. P.N. Nayak which expression shall, unless it be repugnant to the meaning or context thereof be deemed to mean and include its successors and assigns

AND

"KLE Society's G I Bagewadi Arts, Science And Commerce College, Nipani" having its presence in District Belagum, Pin code - 591237 offering technical diploma / under graduation courses for B.Com, BA, B.Sc., B.Ed., BBA, Diploma represented by its Prof. Shankarmurthy KN (hereinafter referred to as "Partner College", which expression shall, unless repugnant to the meaning or context thereof, be deemed to mean and include its successors and permitted assigns)

AND

DESHPANDE SKILLING and The PARTNER COLLEGE are hereinafter collectively referred to as 'Parties' and individually as a 'Party'.

WHEREAS:

- 1. DESHPANDE SKILLING a "not for profit" trust, an impact unit of Deshpande Foundation, India, and a training partner of National Skill Development Corporation (NSDC), involved in the activity of conducting residential employability skills training programs for graduates of rural and semi urban colleges at its skilling campus in Hubballi, and providing placement assistance to its students. Deshpande Skilling is desirous to bring about rural transformation by building employability skills among graduate youth from rural and semi urban colleges and assist them earn their first employment in the formal sector. Deshpande Skilling wishes to admit job seeking students who pass out of college, but have failed to acquire the required skills to earn employment to its skilling program.
- DESHPANDE SKILLING collects a fee from the students enrolling for the residential skilling program with the objective of ensuring ownership of the student in the exercise. The quantum of fees forms only part of the cost of the activity.

DESHPANDE SKILLING neither earns nor is desirous of any profit from the activity of skilling.

- The PARTNER COLLEGE is desirous to see more of its students succeed to earn their employment in reputed organizations and also enhance its own placement record.
- The two parties, DESHPANDE SKILLING and The PARTNER COLLEGE seek to partner with each other, to achieve the common goal of skilling graduate pass outs, and thereby succeed in starting their working career.
- The principal and staff of the PARTNER COLLEGE will identify and recommend to DESHPANDE SKILLING names of final year students of the college who and inclined to join a job after graduating but are lacking in skills critical to earn their placement.
- The principal and staff of the PARTNER COLLEGE will also identify deserving students who are financially challenged for concession in fees, and recommend same to DESHPANDE SKILLING.
- DESHPANDE SKILLING will select students from the list recommended by the PARTNER COLLEGE and offers to admit, train and provide placement assistance to students who join the various programs.
- DESHPANDE SKILLING offers skill training and placement assistance to students
 of many colleges and will form training cohorts of students from multiple colleges.
 Students of the PARTNER COLLEGE will be provided with common facilities and
 training services as all other students in training.
- 9. DESHPANDE FOUNDATION will offer concessional fee structure to the financially challenged students as per recommendation of the PARTNER COLLEGE principal. The total concession amount available to the students of the PARTNER COLLEGE will depend on the number of admissions, and will be mutually decided by the two parties.
- 10. The Parties recognize the capabilities and resources that each party brings, and agrees to use their best efforts to bring together those capabilities and resources to collaborate for the purpose of supporting skill-based training with DESHPANDE SKILLING. The PARTNER COLLEGE will support by identifying and counselling job seeking students to take benefit best from the skilling program. DESHPANDE FOUNDATION will support by skilling and placing students of the PARTNER COLLEGE and enhance its placement rate.

- 11. DESHPANDE SKILLING will work with the PARTNER COLLEGE to build a mindset of preparing early to earn a placement and start career among select students of the partner college. The 2 parties will agree on an annual activity calendar that could include group counselling and Q&A session, interaction with Alumni of the college who have been successful, remote classes for students, and any other activities that could give students awareness and exposure.
- 12. DESHPANDE FOUNDATION will also extend invitation to staff of the PARTNER COLLEGE to attend trainings and workshops that it will conduct on Skills Development for employability and other such areas that can contribute to enhancing placement record of the PARTNER COLLEGE.

The Parties are therefore entering into this MOU to record the terms and conditions of this collaboration. DESHPANDE SKILLING and THE PARTNER COLLEGE have agreed to enter into this MOU to record their present state of agreement in principle in respect of the UBER College Partnership Program.

NOW IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

This collaboration between DESHPANDE SKILLING and THE PARTNER COLLEGE will be to impart skill training and provide placement assistance to select students of "THE PARTNER COLLEGE" to be able earn their first employment. The objective of this partnership is to facilitate rural transformation by getting rural youth into productive employment, and to enhance the placement record of the partner college.

Roles & Responsibilities of PARTNER COLLEGE:

- Party would enter in MOU for the DESHPANDE SKILLING's "UBER College Partnership Program" for Skill development Training for interested students of The PARTNER COLLEGE.
- PARTNER COLLEGE will support the program by recommending about 30 most suitable students of the college each year for the residential skilling program for graduate students conducted by DESHPANDE SKILLING at its Skilling campus.
- PARTNER COLLEGE will recommend students from BA / B.Com/B.Sc. / BBA / BCA / B.Ed. /Technical Diploma / ITI streams only.
- 4. PARTNER COLLEGE will apply adequate justification for recommendation of each student for admission. The recommendation will be an informed decision that the student would benefit from the skilling program and the student and his/her family has a high "need for job".

- PARTNER COLLEGE will avoid recommending candidates who already possess good employability skills, or candidates who are extremely low on employability skills or candidates who are not keen to start their working career immediately.
- PARTNER COLLEGE will permit and facilitate representatives of DESHPANDE FOUNDATION to interact with the recommended students and their parents at the college for counselling before admission to the program.
- The PARTNER COLLEGE will not have objection to DESHPANDE SKILLING collecting a part of the cost of skilling each student, in the form of fellowship fees from the students.





Memorandum of Understanding Agreement

This Memorandum of Understanding Agreement is entered into as of 16th August 2022 between BygC Solutions Private Limited [CIN: U74999KA2020PTC131375], a company incorporated under the laws of India and having registered office at B6, Sterling Villa Grande, Kadugodi, Whitefield, Bangalore – 560067 INDIA (hereinafter referred to as the "BygC" which expression shall unless repugnant to the context shall mean and include its successors and assigns) AND Placement Cell, KLE Society's G I Bagewadi Arts, Science and Commerce College. Old P B Road, Nipani. Belagavi (District) 591237 INDIA (hereinafter referred to as "Institution" which expression shall unless repugnant to the context shall mean and include its successors and permitted assigns).

WHEREAS BygC is primarily engaged in the business of providing online and offline courses in various domains and generally offers their courses to those candidates who qualify the selection criteria;

WHEREAS Institution is an Academic Institution providing UG and PG Education in Arts, Science and Commerce, who could provide prospective Candidates for the Courses offered by BygC;

AND WHEREAS following discussions, the Institution has agreed to propose the Courses to Candidates and BygC has agreed to offer the Courses to the Candidates, as per the terms and conditions of this Agreement.

NOW, THEREFORE, IT IS AGREED BETWEEN THE PARTIES AS FOLLOWS:

DEFINITIONS:

In this Agreement unless in consistent with the context or otherwise specified the following definitions shall apply:

- Confidential Information shall mean and include Content, Personal Data, results of any
 services, all materials and/or information including without limitation all BygC data,
 whether or not marked or otherwise identified as confidential, whether written, oral,
 graphic or ascertainable by inspection of tangible objects and any other subject matter
 which by its nature would be reasonably known to be confidential or proprietary, and all
 copies thereof.
- Content shall mean the learning material of BygC, whether in the video, audio, word, power point or any other format and also includes the materials/information generated by virtue of interaction between the Candidate and personnel/faculty of BygC.





- Courses shall mean those courses offered by BygC which shall be communicated from time to time by BygC with the Institution.
- Intellectual Property Rights or IPR: means all trade secrets, patents and patent applications, trade marks (whether registered or unregistered and including any goodwill accrued to such trade marks), service marks, trade names, business names, internet domain names, e-mail addresses, copyrights (including rights in computer software), moral rights, database rights, design rights, rights in know-how, rights in confidential information, rights in inventions (whether patentable or not) and all other intellectual property and proprietary rights (whether registered or unregistered, and any application for the foregoing), and all other equivalent or similar rights which may subsist anywhere in the world.
- "Party" means BygC or Institution severally and "Parties" means BygC and Institution collectively.
- Candidates shall mean the candidates proposed by Institution to BygC for the Courses, who have cleared the selection criteria and who have joined the Courses after making required payment to BygC.

REFERRAL AND SELECTION PROCESS:

- The Institution hereby agrees to introduce the Courses to the Candidates including alumni, so as to generate interest in them to join the Courses. The Institution shall inform BygC, in writing, with the list of prospective Candidates with details, once the Courses are introduced to them.
- On receipt of such list from the Institution, BygC shall conduct basic course counselling for them and offer them an evaluation process to see whether they qualify to join for the Courses.
- BygC shall offer the Courses to those Candidates who have qualified such evaluation process.

IMPARTING COURSES:

 BygC shall, impart the Courses to those Candidates who have joined the program after making requisite payments to BygC. The Courses will be imparted in accordance with the standard teaching procedure and methodology of BygC.





REVENUE SHARE AND PAYMENT TERMS:

- In consideration of introducing the Courses and referring the prospective Candidates to BygC and for all other services provided, BygC shall pay the Institution a portion of the revenue it has actually received from each Student, the details of which shall be communicated by BygC from time to time to the Institution.
- All amounts payable under this Agreement shall become due to Institution only on receipt
 of the corresponding amount by BygC from the respective Student. Institution shall raise
 an invoice when the amounts are due and shall be payable by BygC within thirty (30) days
 from the date of receipt of the correct invoice.
- All the amounts payable under this Agreement are inclusive of any GST, sales, excise, value-added, services, or other tax, duties, levies and other statutory charges, costs and fees imposed by any taxing jurisdiction and shall be paid by the Licensee. If BygC is required by law to make any deduction or withholding from any payment due hereunder, then BygC shall deduct and pay such amounts to the statutory authority within the prescribed time and shall provide the Institution with a certificate to such effect.

WARRANTY AND LIMITATION OF LIABILITY:

- Each Party represents and warrants that they have the right, power and authority to enter into this Agreement and duly perform its duties hereunder.
- BygC may make all commercially reasonable efforts to provide placement support to the Candidates who have successfully completed the Courses and where such support is mentioned as part of the said course program. Such support shall be in accordance with the placement policy of BygC. Notwithstanding anything contained herein, BygC expressly disclaims any guarantee to provide placements to any Student.
- Except for the warranties stated above, BygC expressly disclaims all warranties to the
 extent permitted by law.
- No party shall be liable in any event for any special, consequential, incidental, or indirect damages arising out of or in connection with this Agreement. The total liability of BygC under this Agreement is limited to amounts paid by BygC to the Institution.





TERM AND TERMINATION:

- This Agreement shall be effective on the Effective Date and shall remain in force for a
 period of one (1) year thereafter, unless terminated as provided herein. The Parties may
 mutually agree in writing to extend the term of the Agreement beyond such period.
- A Party shall have the right to terminate this Agreement for no reason, with a prior written notice of thirty (30) days.
- Either Party may terminate this Agreement and the license and rights granted herein
 immediately upon written notice to the other Party (without forfeiting any other remedies
 which it may have) if (i) a Party breaches any of the material provisions of the Agreement
 and/or (ii) such other Party has been adjudicated bankrupt, insolvent or liquidated by a
 court of competent jurisdiction.

GENERAL:

- Each party shall keep confidential all Confidential Information received from other party
 under this Agreement and shall not disclose such Confidential Information to any third
 parties without the prior written permission of the disclosing party or use them other than
 for the purposes specifically permitted under this Agreement. The confidentiality
 obligations herein shall survive the expiry or termination of the Agreement.
- This obligation for confidentiality shall not apply to information (i) which is in the public domain at the time of disclosure to the parties; or which later becomes part of the public domain through no breach of this Agreement; or (ii) the receiving party can demonstrate to the satisfaction of the disclosing party was in its possession, without any restrictions, prior to disclosure by the other party or (iii) is acquired by the receiving party from a third party without any restrictions, which has a legal right to disclose such Confidential Information; or (iv) the receiving party is obliged to disclose under law or by the order of a competent Court, Government or any other statutory authority.
- This Agreement shall be governed by and construed in all respects in accordance with the laws of India. Any dispute and/or difference arising out of or pertaining to this Agreement, shall first be resolved by the Parties through personal negotiations involving senior management, failing which it shall be referred to and finally resolved by arbitration administered in accordance with the Arbitration and Conciliation Act 1996, which rules are deemed to be incorporated by reference in this clause. The seat of the arbitration shall be Bangalore. The language of the arbitration shall be English. Both parties subject





themselves to the exclusive jurisdiction of court at Bangalore.

This Agreement constitutes the entire agreement between the Parties, and supersedes any prior understandings relating to the subject matter hereof, and may be amended or supplemented only in a written form signed by both the Parties. If any term, condition, section or provision of this Agreement becomes invalid or be so judged, the remaining terms, conditions, sections and provisions shall be deemed severable and shall remain in force. The failure to exercise, or delay in exercising any right, power or remedy vested in this Agreement shall not constitute a waiver by that party of that or any other right, power or remedy. Nothing in this Agreement shall constitute or be deemed to constitute a partnership, joint venture or agency between the Parties hereto and both of them shall have no authority to bind the other in any way.


